- 5. Violation of any of the conditions laid down in sub-para (3) and sub-para (4) shall entail withdrawal of this no-objection of the State Covernment with effect from the beginning of the next academic year.

I have the heneur to report that the above named private Educational Institution was issued with a "No objection certificate" vide m me No 691-SE(S) dt, 28.11.96, and accordingly it was affiliated with "Central Board of Secondary Education" with effect from 1.4.99, vide memo. No. CBSE/AFF/24358/99/5368-72 dt, 7.7.99, having the address-" Modella Caretaker Centre & Schools, 27-Church Road, Siliguri Dist.- Darjeeling.

In the said affiliation order, the School Authority was directed to complete the construction at the new site and to shift the school to the said site(pare-21). The new site of the school is located in the address-" Vill-Jatiakali, P.O. Fulbari, G.P.-Fulbari II, under Rajganj Block, P.S. Bhaktinager, in the district of Jalpaiguri" Again when the School Authority, applied for upgradation of the school, they CBSE/Aff/24358/2003/4264 dated, 22.11.02, raised the question that the new address of the school differs from that as noted in the No Objection Certificate and directed the school authority to get the No.O.C corrected/ medified with permission to shift the school.

On request from the school authority, an enquiry was held on 20.12.02 by Sri P.Das, S.I. of School (SE) and he reported that the school was shifted to the new building constructed in the new site and it is running in the new address as noted in previous para.

Therefore, I recommend the case for according post factor approval towards shifting of the school to the new address for getting recognition of the up-graded section/classes at an early date.
